

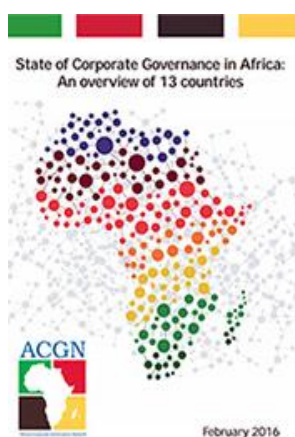

We are in discussion with EY on the updating of the report to ensure that it remains relevant and up-to-date and to broaden the scope of coverage across the continent.

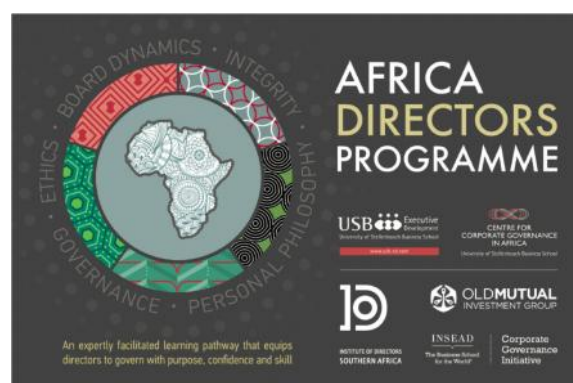
ACGN CHAIRMAN TO ATTEND THE OECD GLOBAL KNOWLEDGE SHARING ROUNDTABLE

Said Kambi, ACGN Chairman, will be attending the OECD Global Knowledge Sharing Roundtable on Corporate Governance of State-owned Enterprises in Mexico City from 7 – 8 June 2016. Said will moderate the first session entitled “Recent reform efforts: An overview of the revised OECD Guidelines on the Corporate Governance of State-Owned Enterprises” in the plenary session. This event will provide an opportunity for knowledge sharing, networking and promoting of the objectives of the ACGN through creation of linkages to the OECD.

OPEN GOVERNMENT PARTNERSHIP AFRICA CONFERENCE

NBF attended the Open Government Partnership (OGP) African Regional Conference in Cape Town on 5-6 May 2016. This conference was hosted by the South African Department of Public Service and Administration. The conference served as a space for participants from African countries to highlight good practices and successful initiatives, discuss challenges being faced, establish support and build on regional peer exchange mechanisms. Of particular interest were the areas of synergy between the OGP and APRM. OGP was launched in 2011 to provide an international platform for domestic reformers committed to making their



governments more open, accountable, and responsive to citizens. The OGP is a voluntary initiative with 10 African countries that have signed up out of a total 69 participating countries.

The IOD Mozambique hosted a series of meetings of the ACGN, including its 2ND AGM, in Maputo from 16 – 19 February 2016. Held over three days the meetings included a business forum with presentations by Baroness Lynda Chalker, Africa Matters and ACGN Ambassador, on Corporate Governance in Africa; Professor Deon Rossouw, CEO of the Ethics Institute of South Africa, highlighting the cardinal values underpinning good governance; and Fred Swaniker, African Leadership Academy, on promoting greater corporate governance in Africa through ethical leadership.

The Maputo meetings also saw the launch of the ACGN EY Research Report on the state of

corporate governance in 13 ACGN member countries.

A strategy session was also held whereby the ACGN identified projects and related working plans aligned to its new working groups of Stakeholder Platform; Governance and Advocacy; and IOD Network Capacity Development.
